RE: REQUEST FOR CERTIFICATE OF "NO OBJECTION" TO ADOPT SELECTIVE TENDERING AND DIRECT PROCUREMENT METHOD FOR SOME PROJECTS UNDER THE AFRICA CENTRE OF EXCELLENCE ON PUBLIC HEALTH AND POLICY

This is to refer to the Bayero University Kano's (BUK) letter Ref. No. VC/V/001 dated December 13, 2021, which requested the Bureau to grant Due Process "No Objection" to the University to adopt Selective Tendering Method for the Proposed Procurement and Installation of Solar Back-up, Supply of 100KVA Generator and 30-seater Bus for ACEPHAP, Bayero University, Kano.

- 2. In the letter under reference, the BUK indicated the following:

 - (b). The Bureau may wish to note that the default method of procurement in the University has been open competitive bidding, which has become difficult and nearly impossible now because of the COVID-19 pandemic which is transmitted through person-to-person contact. Thus, there is need to avoid gathering of people as per COVID -19 protocol which is unavoidable under the open competitive bidding Tendering Method in line with the provision of Section 40 (I) (b-c) of the Public Procurement Act (PPA) 2007 for the execution of the project.
 - (c). As a result, the University writes to request the Bureau of Public Procurement (BPP) to issue the University a "Certificate of 'No Objection' to adopt Selective Tendering' for Lots 1 & 2, while to adopt Direct Procurement Method for Lot 3. We were careful to select only Companies with competence and capacity to execute the projects for your consideration, please.

- (d). It is our hope and prayer that you will approve our request, please.
- 3. The Bureau wishes to draw the attention of the BUK to the Federal Government Policy and Strategy of engaging only Original Equipment Manufacturers (OEM)/Representatives for the Supply of equipment/items and some of the basic principles which govern Special and Restricted Methods of Procurement as stipulated under Section 40 of the Public Procurement Act, 2007 due to urgency which is not the result of dilatory conduct on the part of the procuring entity as follows:-
 - (a). Section 40 (1): Subject to the approval by the Bureau, a procuring entity may for reasons of economy and efficiency engage in procurement by means of restricted tendering if:
 - a. the goods, works or services are available only from a limited number of suppliers or contractors;
 - b. the time and cost required to examine and evaluate a large number of tenders is disproportionate to the value of the goods, works or services to be procured; or
 - c. the procedure is used as an exception rather than norm."

Under the Federal Government Policy and Strategy of engaging only OEM/Representatives, MDAs are expected to procure equipment/items from only OEM/Representatives that will provide the requisite guarantees and after sales maintenance services for the operation of the equipment/items.

- 4. Further findings and observations following the Bureau's review of the submission of the BUK are as follows:
 - (a). The BUK intends to adopt Selective Tendering Method for the Proposed Procurement and Installation of Solar Back-up, Supply of 100KVA Generator and 30-seater Bus for ACEPHAP, Bayero University, Kano. Therefore, the BUK shortlisted three (3) companies each for lots 1 & 2 and one (1) company for lot 3 to participate in the procurement processes.
 - (b). The BUK grounded the request on the need to avoid social gathering due to the COVID-19 Pandemic ravaging the world.

- (c). As evidence of funding, the BUK forwarded for Due Process Review a copy of the Africa Centres of Excellence World Banks allocation with the total sum of \(\mathbb{H}\)341,651,667.07 for the projects.
- 5. The Bureau in recognizing the present condition in the country due to the COVID-19 pandemic which has limited the number of persons expected to congregate is inclined to agree that the adoption of Special and Restricted Method of Procurement can be considered in line with Section 40(1)c of the PPA, 2007.
- 6. The Bureau therefore reviewed the company profile of the firms forwarded to ascertain whether the companies have fulfilled all the responsive requirements in line with Section 16(6) of the Public Procurement Act, 2007, registration in the Bureau's Database and Federal Government Policy and Strategy on engaging OEM/their representatives. The outcomes are as shown in the Table below:

7. The BUK shortlisted only one (1) firm for Lot 3 (procurement of 30-seater Bus), this will not engender the level of competition envisaged in this procurement process. The BUK ought to have shortlisted all the OEM/their representative that assemble similar Buses with similar specification in Nigeria to bid for the vehicle. This is to enshrine competition in the process. The BUK should be properly guided in subsequent procurement and therefore shortlist additional four (4) authorized local Vehicles Assemblers/Manufacturers or their authorised representatives from the approved list provided by NADDC below that are up to date in payments of their taxes and other social security contributions as stipulated in Section 16(6) of the Public Procurement Act, 2007 and Section 127 of the Public Procurement Regulation for Goods and Works which requires the use of specifications based on relevant characteristics, performances, capabilities and qualities for the supply of the vehicle.

- (b).Be guided by the approval Revised Threshold stipulated in SGF's Circular Ref. No. PROC/OSGF/BPP/709/85 dated 19TH January, 2022 in approving the project.
- (c). Ensure that there is valid approved current source of funding for the projects.

- (d).Conduct Due Diligence/Post Qualification in line with the resolution of the Federal Executive Council's (FEC) meeting held on May 17, 2017 and SGF's Circular Ref. No. SGF.50/5.52/III/652 dated October 11, 2017 on the recommended companies before award of the contracts. The Due Diligence Report should include but not limited to:
 - i. Names of the Directors of the Company;
 - ii. Professional and technical qualifications of personnel required to carry out the procurement;
 - iii. Financial capability;
 - iv. Equipment and other relevant infrastructure;
 - v. Verification of adequate personnel to perform the obligations of the procurement contract;
 - vi. Possesses the legal capacity to enter into contract with the Federal Government;
 - vii. Not in receivership, subject of any form of insolvency or bankruptcy proceedings or the subject of any form of winding up petition or proceedings;
 - viii. Have fulfilled all the obligation with regards to payments of taxes, pensions and social security contributions;
 - ix. Not have any Director who has been convicted in any Country for criminal offences relating to fraud or financial impropriety or criminal misrepresentation or falsification of facts relating to any matter.
- (e). The BUK should note that in the implementation of these accelerated procurements for the Goods, all the processes and deliverables are properly kept for future procurement audit as stipulated in Sections 16(12) and 5(p) of the Public Procurement Act, 2007.
